## WINTER HINTS

Here are some winter helpful hints that could make your winters easier to deal with.

Keep your headlights clear with car wax! Just wipe ordinary car wax on your headlights. It contains special water repellents that will prevent that messy mixture from accumulating on your lights – lasts six weeks.

Squeak proof your wipers with rubbing alcohol. Wipe the wipers with a cloth saturated with rubbing alcohol or ammonia. This one trick can make badly streaking and squeaking wipers change to near perfect silence and clarity.

Ice proof your windows with vinegar. Frost on the way? Just fill a spray bottle with three parts vinegar to one part water and spritz it on all your windows at night. In the morning, they'll be clear of ice. Vinegar contains acetic acid which raises the melting point of water preventing water from freezing.

Prevent car doors from freezing shut with cooking spray. Spritz cooking oil on the rubber seals around car doors and rub it in with a paper towel. The cooking spray prevents water from melting into the rubber.

Fog proof your wind shield with shaving cream. Spray some shaving cream on the inside of your wind shield and wipe it off with paper towels. Shaving cream has many of the same ingredients found in commercial defoggers.

De-ice your lock in seconds with hand sanitizer. Just put some hand sanitizer gel on the key and the lock and the problems are solved.

## RECEIPES IN TIME FOR CHRISTMAS

Two neighbors have given us recipes just in time for those big dinners we prepare at Christmastime.

### CHEESY POTATOES

1 pkg hash browns  
1 can cream of chicken soup  
2 cups shredded cheddar cheese  
 $\frac{3}{4}$  cup sour cream  
 $\frac{1}{4}$  cup chopped onion  
 $\frac{1}{4}$  cup butter or margarine, melted

Topping  
1  $\frac{1}{2}$  cups coarsely crushed corn flakes  
2 T butter

Spray 2 quart baking dish with nonstick spray. Combine all other ingredients and spread in dish. Put the topping on and bake for 45” at 350 degrees.

For larger crowds just double the ingredients.

### PEANUT BRITTLE

Use a large sauce pan, at least 4 quarts

Butter well a large cookie sheet with about  $\frac{1}{2}$ ” sides.

Combine

2 cups sugar

$\frac{1}{2}$  cup water

1 cup Karo syrup

Cook until hard ball forms in ice water

Add

2 T unsalted butter

2 cups raw peanuts

Stir over heat until golden brown, not a dark brown. Watch carefully when it starts getting golden color.

Remove from heat.

Quickly stir in


1 T vanilla and 2 t soda

Stir to mix. Mixture will bubble and foam.

Pour onto buttered cookie sheet. Careful ~ mixture is extremely hot !

Let brittle seek its own level ! Don’t smooth the mixture !

Cool, break up with hands, store in an air tight container. You will have some crumbs, they are for “test tasting” with a spoon. Enjoy and wait for the compliments!



**Carrie and Ed Plante**

Home in Little Falls MN on leave from the United States Air Force, Ed Plante met Carrie Guck. This chance happening was the beginning of a 58 year romance. Carrie became a military wife upon their marriage in 1953. While in the Air Force, Ed and Carrie were stationed at Barksdale Air Force Base in Shreveport, LA, then on to a joyous four year assignment at Hickam AFB, Hawaii, where they bought a house. The Plantes added three more children to the two they already had while in Hawaii. Then it was off to Otis AFB, Massachusetts where another child came along to finish off their family of six children. Their final assignment was to Shepherd AFB, Wichita Falls, Texas where Ed retired in 1965. Faced with locating a permanent home for their large family, Ed began checking out several locations. He heard good reports about Colorado Springs and found it perfect in every way ~ close to Fort Carson's commissary, pharmacy and hospital, the interstate, and not far from Denver. They found a house at the corner of Crestridge and Westmark and have resided here in Stratmoor Hills since 1966.

Carrie reflected on her life as a military wife: "It was an adventure. I liked the military life. We met so many wonderful people." Of all the places she lived, Carrie preferred Hawaii. She managed her family as a stay-at-home mom.

Ed started his military career as an aircraft mechanic on B-29 aircraft during World War II. After the war Ed decided to make a career of the AF. First as a crew chief on C-46 airplanes then C-47s when the Korean war began Ed returned to his treasured B-29 as flight engineer and was actively involved in the conflict. Later on as B-29s became obsolete he transferred to KC97s and C124s.

The last five years ending his AF career were spent as a data processing school supervisor until his retirement and move to Colorado Springs.

Too young to retire, Ed hired on as a salesman for several local car dealers and also owned and operated a sandwich shop for 10 years. All the children grown and gone, Carrie went to work for Sears and Exchange National Bank. Nowadays, the Plantes love to travel, read, visit their children (three of whom live in Colorado Springs) one in Virginia and one in Alabama. Unfortunately, their son Glen drowned while scuba diving. Ed served a three-year term on the Stratmoor Sanitation District Water Board. Ed's major occupation in October is cooking for and supervising the Supreme Spaghetti Supper for the SHNA. He also sells more tickets than anyone else. Every year Ed says "I'm not getting involved with that Spaghetti Supper this year," and every October he ends up organizing and supervising this fund raiser. 200 people attended this year to get yet another taste of Ed's pasta sauce, the recipe for which is a secret.

When asked what she likes best about Stratmoor Hills, Carrie replied that Stratmoor is a convenient location, has a good climate, the city is nearby, it is close to Church and downtown and good hospitals. Carrie and Ed are founding members of St Joseph Catholic Church. They belong to the Korean Veterans Association and faithfully attend their meetings. Ed said that there is great hunting in the plains and mountains of Colorado and along with its fabulous scenery, great climate and active and vibrant community what a great place to live.
