

**11 WESTMARK AVENUE
ASSISTED LIVING FACILITY**

An assisted living facility recently popped into our neighborhood without warning. It's going to be at 11 Westmark Avenue in the cul-de-sac. Plans for it were only disclosed at the formal property closing. Likewise, the buyer was a bit surprised as the realtor told him there was no association in the neighborhood. No words as to who the broker was, or what the property sold for. We'll let you know when we learn more. .

The Assisted Living Facility (ALF) was the subject of considerable discussion at the September 2013 meeting. Neighbors are disappointed and disgruntled that a family with children is not moving into the cul-de-sac. They are doubtful that the new people will make an effort to integrate into the community. The new owner ~ a man named Jeff Reynolds who lives in Briargate ~ came to the September meeting to make a short presentation and to answer questions.

Approximately 45 skeptical neighbors attended and heard Mr Reynolds turn out to be an adept presenter, skilled in fielding questions. Here are a few responses to questions put by our neighbors. "No juveniles will live in the building. Elderly only. No dementia people. A person may have two strikes but on the third, they have to move to a memory care unit. There will be no combatives. There will be medical support. We will try to have celebrations at least at Christmas and the 4th of July. We will hire one person to take care

of the patients. Care includes help with bathing, incontinence, preparation of meals, and help negotiating stairs (no elevator.)

A neighbor asked why Stratmoor Hills was selected instead of some other place. Reynolds said he needed a ranch style home and added, "I liked the ambience of the neighborhood." When asked what he will charge residents per month, he hesitated quite a while and then said, "about \$3,000 a month."

He said there will be no wheelchair residents and they are considering an activity director. Describing the requirements by the State, a background check from them, approval from the Fire Department for their access, and sprinklers in the building (whose installation cost may be \$40,000) plus 30 hours of training by the State.

Of most concern to neighbors was turn-around room in the cul-de-sac for rescue, fire and other emergency vehicles, not to mention personal cars already parked there by homeowners.

The facility will generate occupancy with referral services such as "A Place for Mom" and discharge planners at hospitals. They are aiming for a November 1 start up. Home help agencies such as Encompass will go to the ALF to help the residents with such things as meals, bathing, incontinence and other needs of the elderly. The owners will encourage visits by family members to residents. More cars!

"What if a patient doesn't have a family?" inquired a neighbor? Jeff Reynolds replied "They (the patient) must have a power of attorney."

He noted that this will not be a "secure facility" ~ the doors will not be locked. If anyone is a danger to themselves or the neighbors, they do not get in as a resident."

The house intended as an ALF was built in 1994 and has about 3500 square feet of living space. Modifications will be required to accommodate the residents and additional parking space will be needed.

According to the State Statute, zoning regulations provide that a group home for the aged accommodating eight (8) or fewer is allowable as long as it is not within 500 feet of another similar group home. I, the author,

asked about the density of the housing ~ How many to a room? The reply was one to a room unless the room is 120 square feet, in which case there can be two.

A question raised by Bob Colgrove concerned maneuvering the fire truck in case it is needed. Some checking will be done to answer questions about fire regulations as they relate to this proposal.

MORE INFORMATION ON THE ALF

Subsequent to Carl's very well-written article on the ALF, we learned that Constant Care bought the property for \$297,500. The amount financed was \$208,250 at nearly 6%. The rancher has 1,809 square feet of living space, 10 rooms of which four are bedrooms, there are 3 bathrooms, the rancher was built in 1994. Jeff Reynolds has undertaken the renovation of the property so this description will be invalid shortly as he rearranges the house to suit his purposes.



The Constant Care web site listed room rates at one time from \$2,000 to \$4,000 per month. A recent scan of the web site shows that room rates have been deleted.

SOUTH ACADEMY STATION

Ralph Ravenscroft, Manager of the Stratmoor Water and Sanitation Districts, brought us up to date on the progress of South Academy Station, a proposed shopping center on South Academy Boulevard. We first heard about this proposition in February 2013 when the developer visited here from St Louis. He briefly outlined what would happen at the construction site (which has been annexed by the City of Fountain) across from Pikes Peak Community College.

Progress is slow, per Ravenscroft. The developer, UTW Academy Development, LLC, presented a preliminary plan to the Fountain City Council on September 18, but no information has

been released from that meeting. Until approval is received, construction will not be undertaken.

As originally agreed, Stratmoor Hills Water and Sanitation Districts will supply water and sanitation services to the new development. Stratmoor Hills Volunteer Fire Department will provide fire protection according to an intergovernmental agreement between them and the City of Fountain. Police protection is being negotiated between Fountain and the El Paso County Sheriff's Office ~ nothing final yet.

WalMart* and Sam's are still very interested in building at the new shopping center but are conferring with UTW and investigating the possibility of buying the ground upon which they will build their stores, rather than lease the land from the City of Fountain.

Stratmoor Hills Water, Fire and Sanitation will continue to collect property taxes on all structures.

SIDEWALK AND STREET MAINTAENANCE'

We want to make sure our Stratmoor Hills receives as much most needed maintenance as possible.

Stratmoor Hills has offered a safe home for my family and I am confident that if my brother, who is four, were to walk the same route every day that I do, he would arrive safely too. I am so grateful that my family and I have formed so many valuable friendships with unique people because of this place we call Stratmoor Hills.




